The Cardholder for themselves and on behalf of Applicant further agrees to pay interest to WRI on all invoice(s) and balances thereunder until fully paid at the lesser of 1.5% per month (18% per annum), calculated and payable monthly from the date of such invoice(s), together with all collection costs, legal fees and court costs incurred by WRI to enforce and collect payment of such invoice(s) and balances thereunder.
Use of Information	The Cardholder hereby consents to the collection, use and disclosure of his or her personal information in order for WRI to determine his or her credit worthiness, to meet requests for products and services by Authorized Persons, to administer accounts and to comply with legal requirements. Without limiting the foregoing, the Cardholder hereby consents to the disclosure of his or her personal information to third parties where required in order to obtain credit reports and credit references and to otherwise determine his or her credit worthiness. In addition, the Cardholder hereby authorizes WRI to disclose to third parties, including one or more credit reporting agencies, any delinquencies by Applicant and/or the Cardholder in paying invoice(s) and balances thereunder.

Termination	The Cardholder's obligations hereunder may be canceled only by written notice delivered to WRI by registered mail or courier. Upon receipt by WRI of such cancellation notice, the Cardholder shall not be liable for any further extensions of credit to Authorized Persons; however, the Cardholder shall continue to be liable for all indebtedness incurred prior to the date of WRI's receipt of the cancellation notice, together with all pre- and post- cancellation interest, collection costs, legal fees and court costs incurred by WRI to collect any indebtedness incurred prior to the date of receipt of the cancellation notice.
